## **AUTHORIZING RESOLUTION**

(Fast Linen Service, Inc. – Extension of Sales/Use Tax Exemption Benefits)

A regular meeting of the City of Yonkers Industrial Development Agency was convened on Tuesday, February 24, 2015.

The following resolution was duly offered and seconded, to wit:

Resolution No. 02/2015 - 08

RESOLUTION AUTHORIZING THE CITY OF YONKERS INDUSTRIAL DEVELOPMENT AGENCY TO (i) EXTEND THE AGENT STATUS OF FAST LINEN SERVICE, INC. (THE "COMPANY") IN CONNECTION WITH A CERTAIN PROJECT (MORE FULLY DESCRIBED BELOW), AND (ii) EXECUTE AND DELIVER AN EXTENDED SALES TAX EXEMPTION PACKAGE AND EXTENDED NYS FORM ST-60, EACH EXPIRING DECEMBER 31, 2015, AND RELATED DOCUMENTS

WHEREAS, by Title 1 of Article 18-A of the General Municipal Law of the State of New York, as amended, and Chapter 83 of the Laws of 1982 of the State of New York, as amended (hereinafter collectively called the "Act"), the CITY OF YONKERS INDUSTRIAL DEVELOPMENT AGENCY (hereinafter called "Agency") was created with the authority and power to own, lease and sell property for the purpose of, among other things, acquiring, constructing and equipping civic, industrial, manufacturing and commercial facilities as authorized by the Act; and

WHEREAS, the Agency previously appointed FAST LINEN SERVICE, INC. the true and lawful agent of the Agency to undertake a certain project (the "Project") consisting of: (i) the acquisition by the Agency of a leasehold interest in certain land located at 945 Nepperhan Avenue, City of Yonkers, New York, and the existing improvements located thereon (the "Land") consisting principally of an industrial/commercial storage building (the "Existing Improvements"); (ii) the reconstruction, renovation, refurbishment and equipping of the Existing Improvements, including but not limited to, the running of plumbing lines, electrical work and trench work, all for use by the Company as an operating linen service business (collectively, the "Improvements"); and (iii) the acquisition of and installation in and around the Existing Improvements and Improvements of certain items of machinery, equipment and other items of tangible personal property (the "Equipment" and, collectively with the Land, Improvements and the Existing Improvements, the "Facility"); and

WHEREAS, in connection with the Project and to effectuate the agent status of the Company, the Agency executed, among other things, a certain sales tax exemption package (the "Sales Tax Exemption Package") and an NYS Form ST-60, "IDA Appointment of Project Operator or Agent"; and

WHEREAS, the Company has requested that the Agency extend the term of the Sales Tax Exemption Package and NYS Form ST-60 to December 31, 2015, to provide additional time for the Company to complete the Project; and

WHEREAS, the Agency desires to adopt a resolution extending the agent status of the Company to December 31, 2015, and authorizing the execution and delivery of a Sales Tax Exemption Package and NYS Form ST-60 expiring December 31, 2015.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE CITY OF YONKERS INDUSTRIAL DEVELOPMENT AGENCY AS FOLLOWS:

Section 1. The President, Chairman and/or Vice Chairman of the Agency are hereby authorized, on behalf of the Agency, to extend the agent status of the Company to December 31, 2015, and execute and deliver a Sales Tax Exemption Package and NYS Form ST-60 expiring December 31, 2015. The Agency is further authorized to file the NYS Form ST-60 expiring December 31, 2015, with New York State Tax Department's IDA Unit.

Section 2. The officers, employees and agents of the Agency are hereby authorized and directed for and in the name and on behalf of the Agency to do all acts and things required and to execute and deliver all such certificates, instruments and documents, to pay all such fees, charges and expenses and to do all such further acts and things as may be necessary or, in the opinion of the officer, employee or agent acting, desirable and proper to effect the purposes of the foregoing resolutions and to cause compliance by the Agency with all of the terms, covenants and provisions of the documents executed for and on behalf of the Agency.

Section 3. These Resolutions shall take effect immediately.
